How to apply?

Interested candidates may apply for this programme by filing in the attached application form. We are inviting the candidates to send their applications to you **before May 9th, 2025. We can receive applications until May 12th.** We are very much aware that these dates might be placed during vacation time but we must give selected participants time to book their flight tickets and find a hotel.

We will inform you the results of the selection process and send you the confirmation documents latest on May 16th, 2025.

Selection Process

Only complete applications will be retained. Candidates with the most relevant profiles in reference to the target group and with pertinent motivations are most likely to be selected. Do not hesitate to motivate the candidates or take the time to express their motivations to participate.

The seminar and the exam will be conducted in English without any translation. Therefore, a very good knowledge of English is essential to ensure all participants maximise their benefit from the course and enhance the chances to succeed in the exam.

Candidates who successfully complete the examination will receive the certificate of completion co-signed by the Luxembourg Banker's Association ABBL: "**Certified Cloud Officer & Outsourcing Officer**". This will certainly be a fantastic asset for their career!

Looking forward to receiving applications from your country to this innovative training programme.


